

## **New International Student Scholarship from International College of Innovation, National Chengchi University**

- Article 1 New International Student Scholarship (hereinafter referred to as “Scholarship”) is formulated based on "國立政治大學外國新生獎學金申請辦法<sup>1</sup>" and "國立政治大學大學部學生助學金實施辦法<sup>2</sup>". To promote the development of internationalization and drawing outstanding students to International College of Innovation (hereinafter referred to as “College”), the College prescribes these guidelines for awarding this Scholarship.
- Article 2 The College’s Admissions Committee issues the Scholarship based on incoming international students’ application materials. The College's Admissions Committee shall be represented by the full-time faculty of the College or nominated by the dean.
- Article 3 This Scholarship is applicable to incoming international students enrolled in the College’s Bachelor degree program and who have not received financial aid or scholarships from the Ministry of Education, the Ministry of Foreign Affairs, other government institutions, any NCCU or non-NCCU entities. The term “incoming international student” in this guideline is based on "國立政治大學外國學生入學辦法<sup>3</sup>".
- Article 4 This Scholarship includes Full Scholarship and Partial Scholarship; The number of Scholarship awarded by the College shall be determined on a yearly basis and in line with the amount of annual budget allocations.
- (1) Full Scholarship: This scholarship provides NT \$150,000 and first-year tuition fee waiver.
- (2) Partial Scholarship: The scholarship provides first-year tuition fee waiver.
- Article 5 Scholarship will be remitted to the university’s designated financial institutions for the Scholarship recipients after enrollment.
- (1) NT \$ 150,000 will be remitted on a monthly basis, which is NT \$ 12,500 per month.
- (2) The tuition and fee will be paid by the student first. By completing the enrollment and delivering the tuition statement and the payment receipt to the College before the deadline<sup>4</sup>, the tuition and fee’s reimbursement will be transferred afterwards.
- Article 6 Approved recipients shall act as ambassadors of the College, and are obliged to assist relevant activities, including but not limited to international admissions activities, international academic conferences, and general activities of the College and NCCU.

- Article 7 Scholarship recipients are required to complete all procedures within the deadline as stipulated in National Chengchi University's enrollment notice. Those who apply for deferred enrollment, leave of absence, drop out or transfer will not be awarded this Scholarship.
- Article 8 Scholarship shall be rescinded for recipients who have been found to have submitted falsified or inaccurate application materials. All previously awarded amounts must be returned to the College.
- Article 9 These guidelines shall be implemented after being approved by the College Affairs Council, and shall be submitted to the Student Affairs Office for the reference. The same procedure shall apply to any amendments made in the future.

**These guidelines are adopted in Chinese, which shall prevail in case of any discrepancy between the English translation and the Chinese original.**
